

Despite challenges with this Administration's policies, **our district received over \$50 million in federal grant funding for our community** to strengthen infrastructure, expand early childhood education, and support economic growth.

I also worked hard to secure the inclusion of **\$16.7 million in House legislation for projects across our communities, placing us among the top two New Jersey House offices that secured the most funding**. If enacted, the funding will enhance public safety, improve water quality, and make other vital community investments. These investments address critical needs and help create safer, more accessible communities for everyone.

Lowering Costs

Making life more affordable for our residents is one of my top priorities. Under policies pushed by the Trump Administration, the cost of everyday necessities has gone up, putting more pressure on working families. That's why I'm fighting to lower healthcare and energy costs, protect programs like NJ FamilyCare and Medicare, and help families stay ahead.

Since January, I've been out in the community, attending more than 40 events focused on affordability. Our team has also held 14 roundtables and listening sessions with working families, seniors, and small business owners to hear directly about how rising costs are affecting their lives—and what relief would make the biggest difference.

Throughout the year, I've pushed back against policies that would raise energy prices and held House Republicans accountable for supporting actions that drive up costs. I've pressed for lower electric bills and demanded answers from regional grid operators like PJM and federal agencies such as the Department of Energy (DOE) about how data centers are contributing to higher energy costs.

At every step, I've also opposed efforts to cancel offshore wind, solar, and clean energy projects—projects that strengthen our power grid, reduce long-term energy costs, and help keep bills affordable for families.

MENENDEZ, BEYER CALL ON POWER GRID OPERATOR TO LOWER ENERGY COSTS



Congressman Rob Menendez joined Congressman Don Beyer and 20 Members representing districts within the PJM Interconnection service territory, the largest power grid operator in the United States, to demand that PJM take key steps to address skyrocketing energy bills for American households.

The Members stressed that PJM must use current information and technologies, particularly on batteries and Alternative Transmission Technologies (ATTs), to fully comply with FERC Order 2023 and lower energy costs.

I led legislation to increase transparency in prescription drug pricing and to lower out-of-pocket costs for Medicare beneficiaries—important steps to help families and seniors better afford the care they need.



In a year defined by pivotal debates and acts of resistance, I fought back against sweeping Medicaid cuts, joining my House Energy and Commerce Committee Democratic colleagues in a 26-hour defense of healthcare and lifting up stories of constituents who rely on Medicaid.

Standing up for our Immigrant Communities

Immigrants strengthen our country. I see that every day in the communities I proudly represent. So, when the Trump Administration carried out one of their first mass raids in Newark, I fought back. My colleague Congresswoman LaMonica McIver (NJ-10) and I immediately demanded answers from the Department of Homeland Security (DHS) about the mass raid in defense of our immigrant friends and neighbors.

Defending everyone who calls our community home is a fight I will always take on, and I'm not backing down. **Since the January ICE raid, our team has distributed more than 1,500 "Know Your Rights" flyers in over 10 languages.**

In May, during an oversight visit to Delaney Hall with Congresswomen Bonnie Watson Coleman (NJ-12) and LaMonica McIver, we were met by 20+ masked, armed ICE and HSI officers who attempted to impede our legal oversight visit. As Members of Congress, we are legally permitted to conduct unannounced oversight at DHS facilities, something we had already done twice this year. Throughout the visit, ICE attempted to intimidate those involved and obstruct our oversight efforts. The events of that day led to national attention on Trump's overreach on immigration enforcement and put us at the center of this fight.

After hearing reports of unsafe conditions, I went back to Delaney Hall with Senator Andy Kim to meet with officials and later joined my New Jersey colleagues in demanding humane conditions at all detention facilities, including by ensuring visitors are treated with dignity when seeing their loved ones.

We will continue conducting oversight, holding agencies accountable, and ensuring that every person is treated with basic human dignity. That includes continuing our work to close privately run detention centers and speaking out against aggressive enforcement tactics.

As Vice Chair of Policy of the Congressional Hispanic Caucus, I have led efforts to demand accountability for ICE officers who fail to identify themselves during arrests. I also led my Hispanic Caucus colleagues in a letter to DHS calling for an end to illegal restrictions on detention oversight.

And throughout the year, I spoke out forcefully against anti-immigrant policies at agencies, including the Department of Housing and Urban Development (HUD), because we must consistently defend immigrant rights and the values that make our country stronger.

Supporting Children, Education, & Small Businesses

Investing in our children is vital to building a stronger future, which is why I've always prioritized federal funding for early childhood education. **This year, I've helped bring back over \$15 million for Head Start and early childhood education in our communities.**



When the Trump Administration froze critical education funds, threatening our schools, I joined forces with my New Jersey Democratic colleagues demanding the release of \$162 million in K-12 and adult education funding. Through our efforts, the funding was released in time for the new school year.



As a founding member of the Dads Caucus, I've focused on bipartisan efforts to support families and small businesses, including introducing legislation to expand access to diaper-changing stations, by offering tax credits to small businesses that install them. I was also joined by Congresswoman Ilhan Omar (MN-05) in introducing the *Parental Workforce Training Act*, which would create a pilot grant program to help local workforce boards subsidize childcare for parents participating in job training.

Improving Transportation, Infrastructure & Safety

When the Trump Administration froze funding for the Gateway Project on day one of the government shutdown, putting jobs and our region's economic growth at risk, **I immediately led my New Jersey Democratic colleagues in pushing back, making clear we will not stop fighting to restore funding, keep major milestones on schedule and on budget, and prevent commuters from dealing with rail congestion and continued delays.**

After the funding freeze, Senator Andy Kim and I met with union workers and our state partners to hear directly how this reckless decision impacts their livelihoods and the progress of the nation's largest infrastructure project to date.

As our water systems age, investing in upgrades and overhauls is critical to improving service and lowering costs when you turn on the tap. **That's why I was proud to work with Senator Cory Booker to secure more than \$3.6 million in federal funding for vital water infrastructure upgrades in Hoboken.** We'll continue working to deliver the safe, reliable, modern infrastructure our communities deserve.

I was honored to celebrate **the opening of the new Point-No-Point Bridge in Kearny, a project I supported at the federal level.** This investment strengthens our rail network and keeps our communities moving and growing. And after working alongside community members and riders, **we successfully pushed for expanded PATH services after pressuring the Port Authority last December.** We'll keep working to ensure PATH and all of our transit systems remain reliable and that the service improvements we fought for meet the needs of our community.




Protecting our Communities from Helicopters

We consistently hear from our neighbors that helicopters put their safety at risk and impact their quality of life, which is why I introduced the *Protecting Communities from Helicopter Noise Act* and the *Communities Before Air Tourism Act*, in addition to pressing federal agencies to take stronger action and provide more answers.

Immediately after April's tragic helicopter crash over the Hudson River, I partnered with Congressman Jerry Nadler (NY-12) to introduce **legislation to ban all non-essential helicopters within a 20-mile radius of the Statue of Liberty**. We will not relent in the fight against these helicopters that plague our communities.



Protecting our Environment & Building Resilient Communities

Protecting our environment and building resilient communities is central to our work in Congress. This year, I joined more than 35 hearings and meetings for the House Energy and Commerce Committee, advocating for working families, pressing officials on high energy costs, and supporting climate action.

As a dad who loves spending time at parks across our communities, especially Liberty State Park (LSP), and as a member of the Sustainable Energy and Environment Coalition (SEEC), I will keep demanding transparency and opposing the commercialization that threaten LSP and our green spaces. These incredible places mean so much to all of us, and I'll always fight to protect their unique value to our communities.

Parks bring people together, improve our health, and protect our environment. That's why I introduced the **Community Parks Revitalization Act** to ensure every community, no matter the ZIP code, has access to safe, vibrant green spaces.

Protecting LSP and advocating against the marina expansion

Families in New Jersey see the effects of climate change every day. So when the Environmental Protection Agency (EPA) announced plans to rescind the Endangerment Finding, the foundation of its authority to act on climate, I swiftly led my New Jersey colleagues in pushing back because there is simply too much at stake.

Clean, accessible waterways are essential to resilient communities. **It is long past time to clean up the Diamond Alkali Superfund Site on the Passaic River and hold polluters accountable.** I was joined by Congresswomen LaMonica McIver and Nellie Pou (NJ-09) in calling on the EPA and the Department of Justice (DOJ) to expedite the cleanup and put public health first.

Urban agriculture strengthens our communities by expanding access to nutritious food and supporting local businesses. I introduced the *PRODUCE* Act at LifeCap Farms in Jersey City, which would help give urban growers the tools to expand production, reinforce local food networks, and ensure every family has access to high-quality food.

As threats to our critical infrastructure continue to grow, we need strong collaboration at the Federal Communications Commission (FCC) to keep our communications networks reliable when it matters most. **I was proud that the House passed my bipartisan Communications Security Act to strengthen our telecommunications networks against cyberattacks and natural disasters.**

Looking Forward

As we look ahead to the new year, I remain focused on delivering results for our communities and continuing to fight back against policies that harm our friends and neighbors. I remain committed to lowering costs, protecting our immigrant communities, ensuring access to affordable healthcare, safeguarding critical projects like Gateway, and building a more just future for everyone who calls our community home.

There is important work ahead, and I'm ready to meet this moment, to work alongside you, and stand firm in defense of our values. I will never back down from doing right for our community. There are challenges ahead, but we will meet them - together.
